Shirley Monge celebrated the April birthdays. There was a drawing for the birthday card, lunch certificate and lottery ticket. The winner was Kathy Mitchell. Historian: - Everything has been digitized and this position is currently not needed. DeeDee Karabetsos made a motion for this change. Bert Zeitlin seconded. Motion was approved.
